

ASE 2023 Exhibitor Rules, Terms, and Conditions/Booth Specifications

The Rules, Terms, and Conditions contained herein are intended by ASE to serve the best interests of ASE, the registrants, and exhibitors, and to give notice to applicants and exhibitors of governing Rules, Terms, and Conditions. The Rules, Terms, and Conditions bind all applicants and exhibitors. Violation will result in the ineligibility to participate in future ASE exhibiting opportunities and, depending on the infraction, a fine imposed by ASE. Submission of this signed form is intended by the company listed to be a binding agreement as to the terms and conditions contained herein. The company listed on this application agrees to comply with the policies, rules, and regulations contained in the Exhibitor and Sponsorship Prospectus and Service Kit and all policies, rules, and regulations adopted by ASE hereinafter.

ASE Live Course Application

Payment Information

PAYMENT IN FULL (100%) is required with the signed Exhibit/Sponsorship Application. Invoiced payments are due 30 days upon receipt. All exhibiting companies will receive confirmation of receipt of the application and payment. Upon payment processing, booth assignment confirmations will be provided. No company will be assigned exhibit space prior to payment. No company may exhibit unless full payment for booth space has been received.

Space Cancellation Policy

All space cancellations by exhibitor must be received in writing no later than 30 days prior to the meeting. All sums paid by the exhibitor, less a service charge of 50% of the **total** cost of the exhibition or sponsorship opportunity fee, will be refunded. No refunds will be given for space cancellations received less than 30 days prior to the meeting and obligates the exhibiting company to full payment of rental space and/or sponsorship opportunity fee.

Cancellation of Exposition

This agreement is automatically terminated in the event an ASE Live Course is cancelled due to force majeure or causes beyond reasonable control. As used herein, a "Force Majeure event" shall mean any cause or circumstance beyond the provider's control making it illegal, impossible, or commercially impracticable to hold the event or which otherwise has a materially adverse effect on the ability of the provider to perform its obligations under this Agreement, including, but not limited to: fire; casualty; flood; epidemic; World Health Organization travel advisory or travel alert; earthquake; volcanic eruption; explosion or accident; blockade embargo; inclement weather; governmental restraints; restraints or orders of civil defense or military authorities; act of public enemy; riot or civil disturbance; act or threatened act of terrorism, strike, lockout, boycott or other labor disturbance; venue cancellation; inability to secure sufficient labor; technical or other personnel failure; impairment or lack of adequate transportation facilities; inability to obtain condemnation, requisition, or commandeering of necessary supplies or equipment; local, state or federal laws, ordinances, rules, orders, decrees, or regulations whether legislative, executive or judicial, and whether constitutional or unconstitutional; or acts of God.

Should ASE transition a Live Course to a Virtual Course, all funds received for the ASE Live Course will be automatically transferred to the ASE Virtual Course. If an all-virtual event takes place, ASE will work with exhibitors to provide a virtual exhibiting experience that is equitable to the financial commitment made for the live sessions. Should an exhibiting company choose not to participate an ASE Virtual Course, a refund will be provided minus a 20% non-refundable administrative fee. ASE reserves the right to amend or cancel this agreement at any time based on consideration of expenditures and commitments already made.

Tabletop Exhibit Specifications

Each tabletop will receive the following:

- Five complimentary registrations to be used at the Company's discretion.
 - (4) Exhibitor badge-only registrations, (1) full-access CME registration.
- One draped 6-foot table (two tables for publishers) and two chairs.
- Opportunity to bring one backdrop (maximum width 10 feet, and height (8) feet).
- Opportunity to display up to two (2) echo machines or similar equipment.
- Access to a preconference attendee mailing list. (See application for details.)
- Opportunity to provide company description (50-word) plus company logo featured in the Final Program in the exhibitor section.
- Free access to Wi-Fi.

*All exhibit locations will be assigned after application is received on a first come, first served basis based on specific needs.

Subletting, Sharing, and Exchanging Exhibit Space

Subletting, sharing, apportioning, or exchanging all or any part of a tabletop exhibit is PROHIBITED.

Science & Technology Theaters

Science & Technology Theaters are subject to approval by the American Society of Echocardiography. Upon approval, a confirmation with specifications and deadlines will be provided.

ASE Meeting Code of Conduct

ASE is committed to providing a safe, productive, and welcoming environment for all meeting participants and ASE staff. All participants, including, but not limited to, attendees, speakers, volunteers, exhibitors, ASE staff members, service providers, and all others are expected to abide by this Program's Code of Conduct. This Policy applies to all ASE meeting-related events, including those sponsored by organizations other than ASE but held in conjunction with ASE events, on public or private platforms.

Exhibits are subject to the approval of ASE. ASE reserves the right, even after an application has been approved, to refuse exhibits or to curtail/close exhibits or part of exhibits that do not, in ASE's determination, comply with the rules, terms, and conditions governing ASE Live and Virtual Course; are contrary to ASE's scientific or public policies, positions, statements, or guidelines; or otherwise reflect unfavorably on the character of the meeting. ASE shall have full authority to interpret or amend rules, terms, and conditions and ASE's decision is final. Exhibitors agree to abide by any rules, terms, and conditions that may hereafter be adopted. ASE reserves the right to prohibit any activities on the show floor which have not been expressly permitted through approval of ASE. Companies and organizations who do not have a contract to exhibit on file with ASE are prohibited from participating in the ASE Live and Virtual Course or distributing any materials or any other type of activity within the Exhibit Hall. All issues not addressed are subject to the decision of ASE. Exhibitors and exhibit personnel are expected to wear badges in the Exhibit Hall during exhibit hours and while dismantling. All booths must be open and staffed during exhibit hours.

Americans with Disabilities Act

Exhibitors are fully responsible for compliance with all applicable provisions of the Americans with Disabilities Act (ADA) regarding their exhibit space, including, but not limited to, wheelchair access provisions. Exhibitors shall indemnify, hold harmless, and defend ASE, its officers, directors, agents, members, and employees from and against any claims, liabilities, losses, damages, and expenses, including attorneys' fees and

expenses, resulting from, or arising out of the exhibitor's failure or allegations of exhibitor's failure to comply with the provisions of the ADA.

No Smoking Policy

ASE policy prohibits smoking in all areas at any ASE Live Course at any time during installation, show days, or dismantle. Exhibitors are responsible for ensuring that all individuals associated with the exhibiting company this policy.

Security

Outside of ASE Live Course hours, the Exhibit Hall will be locked. ASE is not responsible for lost or stolen equipment or materials at any time.

Fire and Safety

ASE will also assume no liability for damage or loss of the property of an exhibitor or that exhibitor's employees, contractors, or business invitees, regardless of the cause, unless such injury or damage results from or is caused by the negligence or wrongful acts of ASE. Upon application for exhibit space, each exhibitor agrees to protect, indemnify, and hold harmless the American Society of Echocardiography, A. Fassano & Company, and the contracted venue from any and all claims, liability, damages or expenses asserted against them or incurred by them as a result of, or in connection with, any loss of or damage to property, or injury to persons resulting from, arising out of, or in any way connected with the negligence or wrongful acts of the exhibitor or its agents, servants or employees. In no event shall ASE be liable to an exhibitor for any loss of business, business opportunities or any other type of direct or consequential damages alleged to be due from a breach of this contract. It is understood and agreed that the sole liability of ASE to the exhibitor for any breach of this contract shall be for the refund of all amounts paid by the exhibitor pursuant to this contract, as an exclusive remedy. Exhibiting companies will be held responsible for any damage done to the facility by company employees or contracted personnel. No part of an exhibit, signs or other materials may be posted, nailed, taped, or otherwise affixed to walls, columns, doors, or floor surface in a way that will mar or deface the premises.
